Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On May 30, 2024, I was monitoring the app Whisper, posing as a 14-year-old girl. I was contacted by an individual with the username Monster_Random who advised that he is a 23-year-old male from Toms River, NJ. The conversation continued until June 21, 2024, and the subject advised that he wanted to pay my UC persona to perform oral sex on him. The subject also asked for nude photographs from my UC persona. The male subject then initiated a meet on June 21, 2024, and it was determined that we would meet at iPlay America. The conversation then continued via text message, and it was determined that the subject was using a burner application. An emergent disclosure was sent to Text Now and Whisper. I observed that the subject registered the burner account with the e-mail address yamaha2501@hotmail.com. Units from the High-Tech Bureau then set up surveillance in the area. While on surveillance, the subject sent a photograph of \$200.00 advising that the money could be mine. At approximately 11:11 hours, I received text messages from the subject advising he was near the barbershop located next to iPlay America. The subject advised that he was in a black Honda, unknown model. Surveillance units were unable to locate the vehicle, and after several further text messages, the subject pretended that his mobile device was no longer in service. We then reviewed surveillance footage at iPlay America, and attempted to locate the vehicle with no positive results. On this same date, I sent emergent legal process to Microsoft for the aforementioned e-mail, and I later received the results from Microsoft and Whisper. It was determined that the subject primarily utilized a VPN, but I was able to identify the same IP address which was utilized to login to the Email and Whisper that came back to Comcast. An emergent request was sent to Comcast, who advised that the IP address is registered to a [REDACTED] Dennis Dr, Brick, NJ. I contacted Brick PD who advised that they had an entry for Shane Dempsey at that address. I also conducted open source lookups, and found that a Shane Dempsey possibly lived at the residence, and that [REDACTED] Brick PD contacted me and provided several names including Dempsey's that were associated with the residence. It should be noted that the residence is owned by Dempsey and [REDACTED]. On Saturday, June 29, NJSP was notified that Dempsey made a disclosure to [REDACTED] who then notified another trooper.
