Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:
On 03/19/2025 at approximately 1819 hours, officers observed the defendant, Joshua Huelsenbeck, walking on Route 88 in Brick Township, NJ. Officers knew that Huelsenbeck had an outstanding warrant and moved in to make an arrest. After spotting officers in an unmarked police vehicle, Huelsenbeck was observed removing a large knife from the front of his pants and concealing it inside the back of his pants. Huelsenbeck entered room #7 of the Gas Lite Motel and officers made contact with him at the front door. After exiting the room, he was placed under arrest and a search incident to arrest yielded one (1) hatchet tucked in the rear of his pants, and two (2) knives tucked in the rear of his pants. Also found was a plastic container containing a crystalline substance suspect methamphetamine. Huelsenbeck was additionally charged with violating a Domestic Violence Restraining Order and for possessing a weapon as a "Certain Person Not to Possess Weapons."
