On the above date & time, I (Detective Leonard) met with Mr. Watkins at police headquarters. Mr. Watkins reported to me he would like to document on going issues at his farm (Green Cell Farms) located at 149 Brindletown Road. Mr. Watkins stated he is currently having issues with (2) two males that frequent the farm and he wishes to have them trespassed from the location. The two subjects in question are Casey Russo & William A.K.A Liam McGovern. It should be noted that McGovern is a former employee of Mr. Watkins and left the farm on his own free will on 08/24/2024 when he resigned. I obtained all information from Mr. Watkins about why these individuals were to be removed and I was informed it was because of potential unregistered firearms and use of illegal narcotics on the property. I did ask Mr. Watkins to provide any proof of these allegations to which he could not at this time. Furthermore Mr. Watkins provided video footage of the farm with Casey Russo giving the middle finger to the camera while removing property he was storing there at the approval of Mr. Watkins. There is no proof any of Mr. Watkins property was removed by either individuals at this time. At conclusions of meeting with Mr. Watkins, I then contacted both Mr. Russo and Mr. McGovern via telephone and advised them of the formal trespass from 149 Brindletown Road (Green Cell Farms, This phone calls were recorded for record purposes.

It should be noted 149 Brindletown Road is a farm of multiple businesses and a residence divided into lots. Mr. Watkins leases the 60 Acres to the left of the farm beginning at building number 7. With approval from the property owner, Mr. Russo and Mr. McGovern are able to access the other portions of 149 Brindletown Road and are not to be on the property of Green Cell Farms.
