REFERENCE: Block Party Request – Kettle Court

I have received and reviewed the application for a block party that was submitted to the Manager's Office by Yackov Wechsler; [REDACTED] The event is scheduled for Sunday November 30, 2025 between the hours of 1:00pm and 4:00pm with no rain date scheduled.

Mr. Wechsler is requesting to close Kettle Court at Glen Arden Drive to hold the event. The area has been inspected, and there have been no issues identified. Contingent on the implementation of the below stipulations, the Traffic Safety Unit has no issues with the approval of this event:

- Public Works shall deliver two (2) barricades to Mr. Wechsler's residence on Wednesday, November 26, 2025.
- Following delivery by Public Works, Mr. Wechsler knows he is responsible for storing and properly positioning the barricades just prior to block party beginning.
 - o Two (2) barricades shall be placed at the intersection of Kettle Court and Glen Arden Drive.
- Upon completion of the party at 4:00 pm, Mr. Wechsler shall be responsible for the removal of the barricades and proper storage until Public Works can recover them during normal working hours on Monday December 01, 2025

Mr. Wechsler is aware that access for emergency vehicle must remain open. I also advised Mr. Wechsler of the noise ordinance, and all noise from the block party must cease at 10:00pm which he understood. Mr. Wechsler confirmed his entire block was invited. If any complaints or violations are observed, the permit will be revoked and the road will be immediately reopened.
