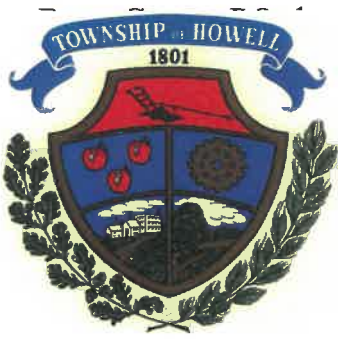

REFERENCE: Block Party Request – Ambiance Blvd

I have received and reviewed the application that was submitted to the Manager's Office for a block party by Samantha Rozza [REDACTED]. The party is scheduled for Saturday, August 16, 2025 between the hours of 12:00pm to 09:00pm, with a rain date of Saturday, August 23rd 2025.

Ms. Rozza has requested to close Ambiance Blvd at both ends, where Ambiance Blvd intersects itself, in the area of 267 Ambiance Blvd. Contingent on the implementation of the below stipulations, the Traffic Safety Unit has no issues with the approval of this event:

- Public Works shall deliver eight (8) barricades to Ms. Rozza's residence on Friday, August 15, 2025.
- Following delivery by Public Works, Ms. Brennan is aware that she is responsible for storing and properly positioning the barricades just prior to the block party beginning.
 - o Two (2) barricades shall be placed at the each of the intersections of Ambiance Blvd and Ambiance Blvd respectively.
 - o Two (2) barricades shall be placed on opposite ends of the event.
- Upon completion of the block party at 10:00pm, Ms. Rozza shall be responsible for the removal of the barricades and proper storage until Public Works can recover them during normal working hours on Monday, August 18, 2025.

Ms. Rozza is aware that access for emergency vehicle must remain open. I also advised Ms. Rozza of the noise ordinance, and all noise from the block party must cease at 10:00pm which she understood. Ms. Rozza confirmed her entire block was invited, and will be getting signatures from them. If any complaints or violations are observed, the permit will be revoked, summonses issued and the road will be immediately reopened.
