At the last Policy Committee meeting on October 10, 2023, board president Chrissy Skurbe challenged the proposed privacy protections for school staff members. Ms. Skurbe said that, last year, several students videotaped a “big fight” at the high school in which staff members were filmed “breaking up” the fight and that this video was used by administrators. Board member Katie Belko said the students who videotaped the fight were disciplined according to the Code of Conduct.

Ms. Skurbe continued, “If it's a policy that you can't videotape and you videotape a teacher hitting another...student....I'm absolutely not saying any of that goes on in our district, I'm just saying, for the sake of this policy, the student would be in trouble for taking that video according to this policy?”

Superintendent Chari Chanley’s verbatim response to this question was as follows:

“Because it says...because under the consequences, we always use the word “may”. So if a principal, if I'm the principal of the elementary school, I'm going to substitute so I won't say what staff members are, a substitute staff member grabs a child by the arm and to discipline them. And the child's fifth grade will say, takes a video of it. I couldn't then the fifth grade would say, “You know you're not supposed to have your phone out, though you drew our attention to something”. This is how I would handle it as principal. That should not have happened. The word “may”. We have, we have policies in place for everything. Child “may” be suspended. It doesn't mean they're gonna be suspended. Every issue is a separate issue. I don't think, and I agree with you. But I don't think looking at Devil's Advocate should stop us from having an important policy. I think the policy needs to go forward. But I would, I would be hopeful that the supervisor, the administrator in charge, would look at it through a gray lens of the child bringing something, God forbid, heinous to an adult’s to an adult’s...” Chanley pauses, struggling to complete her thought. “Attention”, states Carmen Alvarez completing Chanley’s sentence. Chanley thanks her and continues, “Well, on the very bottom of every Code of Conduct, it says point blank, ‘The principal and or administrators have the right at any time, blah, blah, blah.. to over to change anything’. So at any time, it doesn't have to be consequences.”

Thus, it appears a child may not be disciplined for videotaping wrongdoing committed by a teacher and reporting it because administrators have some discretion on how to enforce the policy.
