On 03/16/2025 at approximately 0129 hours, I was performing a Secondary Employment Security post at Vera (2310 RT 70 W).

While conducting this post, a large group of Vera patrons were leaving the business and multiple people started pushing and shoving each other. P/O Bruno #474 and I advanced towards the group of patrons to deescalate the situation and avoid a potential physical altercation. While restraining the groups, I observed a female, Chardonnay Goldsborough begin to punch another patron.

In an attempt to stop the altercation from escalating further, I positioned myself between Chardonnay and the other patrons and assisted Chardonnay to the ground, where she was placed in handcuffs (double-locked and checked for fit). P/O Bruno and I removed Chardonnay from the large crowd of people and away from the area.

When removed from the area, she quickly calmed down and provided police with identification when asked. While I was speaking with her, several other physical altercations began taking place. Chardonnay was informed she was going to be cited with the Cherry Hill Township Ordinance 5-12.7 (Disturbing the Peace). She was then released from custody and left the area without further incident. She was later mailed a copy of her ordinance violation for Disturbing the Peace. Nothing further.

I responded to 2201 Chapel Ave (Jefferson Hospital) for a prisoner watch (Ref case# 25-020038). Upon arrival I made contact with the defendant, Stacey Ivins. While watching Ivins she advised she needed to use the restroom. While allowing Ivins to use the bathroom, when she got up she flipped over the bowl of urine which spilled on the ground. Shortly after, Ivins requested for juice and she was provided with a water bottle. At that point Ivins grabbed the water bottle and threw it on the ground causing the water to splatter on the floor. Ivins continued to behave belligerently, shouting and cursing in a crowded emergency room. As staff members were trying to provide care to Ivins, she was uncooperative and giving them a hard time to do their job. Ivins was ultimately charged with a special complaint form (SC-109392) for Disorderly Conduct (2C:33-2).
