The user name/password were combinations of her personal e-mail and her son's first name. Through the investigation, it was determined after sending Grand Jury subpoenas that a specific IP address was utilized to create the accounts. A grand jury subpoena was then sent for the IP address owner and the defendant was listed as the owner. Defendant was interviewed and confirmed her involvement and apologized.
