Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

During a death investigation of C.M. (DOB [REDACTED]), this officer learned that a surveillance video existed of an incident involving C.M. and his father, Christopher Gregor. On April 3, 2021, detectives from the Ocean County Prosecutor's Office High Tech Crimes Unit secured the surveillance video and placed it into evidence. The surveillance video shows C.M. and Christopher Gregor enter the gym at the Atlantic Heights Clubhouse on March 20, 2021 at approximately 1617 hours. C.M. begins running on the treadmill and Christopher Gregor approaches it, increasing the speed. C.M. is unable to keep up with the increased speed and falls off the treadmill. Christopher Gregor picks up C.M. and places him back on the moving treadmill and appears to bite C.M. on the head. C.M. then falls off the treadmill again. C.M. then tries to get back on the moving treadmill several more times, falling each time.

Sentencing Statement

It is, therefore, on 08/02/2024 **ORDERED** and **ADJUDGED** that the defendant is sentenced as follows:
Defendant was found guilty by jury on May 31, 2024 on Count 1 and Count 2 Amended of Indictment Number 22-07-01332-I and is sentenced as follows:

COUNT 1: Defendant is committed to the Custody of the Commissioner of the Department of Corrections for a term of five (5) years flat.

COUNT 2 AMENDED: Defendant is committed to the Custody of the Commissioner of the Department of Corrections for a term of twenty (20) years. Pursuant to NERA, the defendant must serve 85% of the term imposed before being eligible for parole and five (5) years of parole supervision.

Count 1 is consecutive to Count 2. The NERA sentence on Count 2 is to be served first followed by the flat sentence on Count 1.

Defendant is to receive Credit for Time Served of eight hundred eighty five (885) days on the aggregate twenty five (25) year sentence.

Defendant is to pay monetary penalties as set forth on Page Two. The Superintendent of the institution shall withdraw sufficient moneys in an amount not to exceed 1/3 of the inmates total income as may be required to pay any assessment, penalty, restitution, or fine ordered.
