1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

ON MARCH 30, 2021, THE SUSPECT, CHRISTOPHER WOOD, RESPONDED TO TOMS RIVER MARINE AND MOTOR SPORTS, 3323 ROUTE 37 EAST, TOMS RIVER, NJ, AND PURCHASED DOCKING MATERIALS FROM JERSEY SHORE DOCKS LLC, TOTALING \$4,091.00. (JERSEY SHORE DOCKS LLC OPERATES OUT OF THE SAME LOCATION AS TOMS RIVER MARINE AND MOTOR SPORTS.) THE SUSPECT PRESENTED AN OCEANFIRST BANK BUSINESS CHECK AS PAYMENT, NUMBER 1125, WHICH WAS THEN DEPOSITED BY THE VICTIM INTO A TD BANK BUSINESS ACCOUNT BELONGING TO JERSEY SHORE DOCKS LLC, ON APRIL 1, 2021. ON APRIL 6, 2021, THE VICTIM WAS ADVISED BY TD BANK THAT THE CHECK IN QUESTION HAD BEEN RETURNED DUE TO INSUFFICIENT FUNDS. DESPITE SEVERAL ATTEMPTS AT COLLECTING THE MONEY THAT WAS OWED TO THEM, INCLUDING A LETTER THAT WAS SENT TO THE SUSPECT VIA CERTIFIED MAIL, THE SUSPECT FAILED TO COMPENSATE THE VICTIM FOR THEIR LOSS.
