1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On December 24, 2021, at approximately 1530hrs, I, Ptl DeFeo #16112, responded to Twin Lakes Blvd for a report of a disturbance. Upon my arrival, I spoke with the accused, Christopher Wood, who stated that he was having issues with the residents at [REDACTED] specifically Richard McKinney. He stated that he went to the residence to confront Richard, when Richard ran inside of the residence. I then spoke with other Officers on scene who stated that Richard said that he heard a loud noise, which caused him to walk outside of his residence to find Christopher Wood had used his vehicle to damage a wooden vanity that was placed on their property. Richard stated that he went back into the residence and locked the front door, when Christopher used his foot to kick the door in and enter the residence. Richard said that upon entry, Christopher chased him throughout the residence, to which he entered the bathroom and shut the door, when Christopher yelled "I'll fucking kill you." Christopher then left the scene. While on scene, a footprint was observed on the door showing a cross hatched pattern sole of a shoe. The sole's of Christopher's shoes, which were Vans, matched the markings that were displayed on the door. Christopher admitted to Officers that he kicked the door of the residence, but the door was unlocked and he did not enter the residence once kicking the door.
