Records requested: Paystubs for Parks and Recreation and DPW workers for the year 2024 to present.

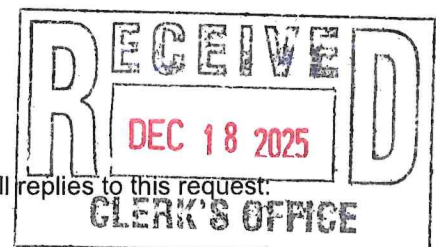
