Accordingly, your request was forwarded to the Police Department that maintains these types of records you are requesting.

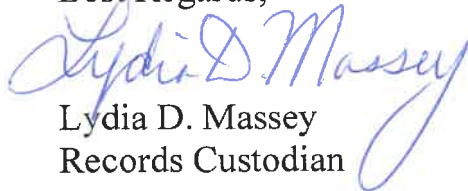
Your request sought access to:
