WHEREAS, N.J.S.A. 40A:5-29, provides for the receipt of donations by the municipality to provide for the operating costs to administer this act; and

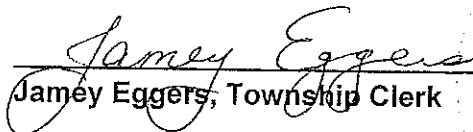
