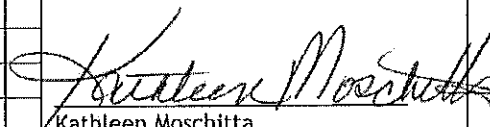

ADDENDUM OF AGREEMENT

ADDENDUM OF AGREEMENT by and between **TEAMSTERS LOCAL UNION NO. 11**, affiliated with the International Brotherhood of Teamsters, located at 810 Belmont Avenue, Suite 200, North Haven, New Jersey and **BOROUGH OF KENILWORTH DPW** located at 567 Boulevard, Kenilworth, New Jersey.

IT IS HEREBY agreed that the following items shall constitute the changes negotiated and agreed to between the parties:

The parties agree as follows:

1. Article 22 – Uniforms

Section 1: Each employee shall receive an annual clothing allowance of \$599.99 for calendar years 2022 and 2023 for the purchase of work-related attire. There is no requirement that the employee provide a receipt for such purchases.
