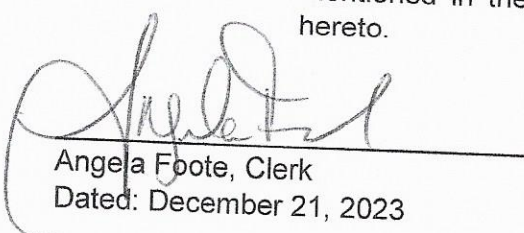

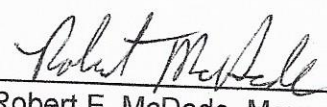
WHEREAS, the Committee has been advised by the Township Clerk that the best way to implement this change is to enter into an amended contract with the Ambulance Union.

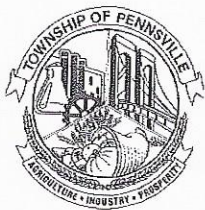

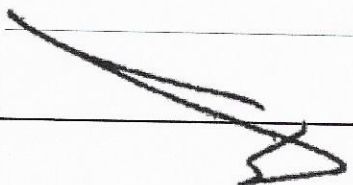
