**RESOLUTION OF THE TOWNSHIP OF WATERFORD
APPROVING A SIDEBAR AGREEMENT WITH THE UNITED
FOOD & COMMERCIAL WORKERS UNION – LOCAL 360**

WHEREAS, a discussion has ensued between Township Officials and Representatives of the United Food & Commercial Workers Union – Local 360 regarding the Township’s hiring of an “A” Mechanic at L-7 and increasing the per hour rate for this position; and

WHEREAS, as a result of those discussions, a Sidebar Agreement has been negotiated between the Township and United Food & Commercial Workers Union – Local 360 to permit the hiring of an “A” Mechanic at the L-7 and revising the per hour rate from \$37.40 per hour to \$46.02 per hour for this position in the Collective Bargained Agreement; and

WHEREAS, all other provisions of the Collective Bargained Agreement will remain unchanged and in full force and effect. Said Sidebar Agreement is attached hereto and incorporated by reference herein.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Township Committee of the Township of Waterford, County of Camden, State of New Jersey that for the reasons set forth hereinabove it hereby approves the Sidebar Agreement attached hereto between the Township and United Food & Commercial Workers Union – Local 360 for the hiring and “A” Mechanic L-7 at a revised rate of pay to \$46.02 per hour.

BE IT FURTHER RESOLVED that this Resolution shall take effect immediately upon adoption.

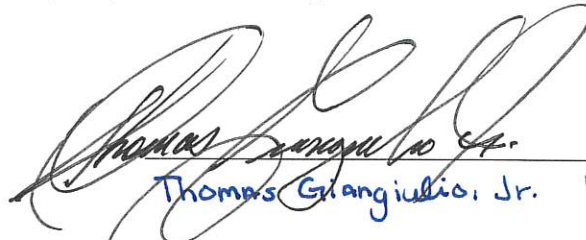
**SIDEBAR AGREEMENT TO THE 2020-2024 EMPLOYMENT
AGREEMENT BETWEEN
THE TOWNSHIP OF WATERFORD AND THE UNITED FOOD &
COMMERCIAL WORKERS UNION – LOCAL 360**

This is a Sidebar Agreement to the 2023-2027 Collective Bargaining Agreement between the Township of Waterford ("Township") and the United Food & Commercial Workers Union – Local 360 ("Union").

The Township and the Union agree to permit the hiring of an "A" Mechanic and revising the L-7 Mechanic per hour rate from \$37.40 per hour to \$46.02 per hour for this position only in the Collective Bargained Agreement. This Sidebar Agreement shall remain in effect during the remaining term of the Collective Bargained Agreement between the Township and the Union.

All other terms and conditions of the Collective Bargaining Agreement shall remain in full force and effect and shall not be changed by this Sidebar Agreement.
