

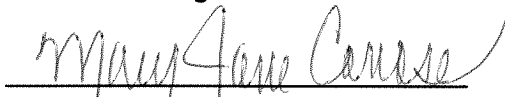

The representatives for the above-captioned parties hereby agree to recommend for ratification the following changes to the January 1, 2009 through December 31, 2011 Collective Bargaining Agreement:

1. Duration – January 1, 2012 through December 31, 2016

2. Wages – January 1, 2012 – 2.0% increase

January 1, 2013 – 2.0% increase

January 1, 2014 – 2.0% increase

January 1, 2015 – 2.0% increase

January 1, 2016 – 2.0% increase

3. Health Benefits – All employees eligible for and receiving health benefits shall contribute in accordance with New Jersey State laws.

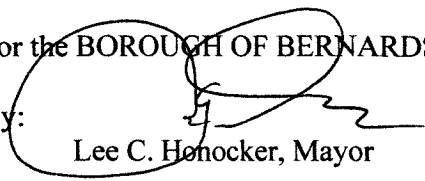
4. Severance Pay on Retirement:
