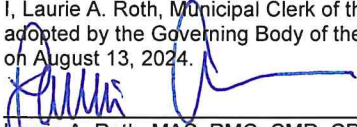

2. All police officers will be compensated at an overtime rate of \$70 per hour for all grants worked, which include but are not limited to Drunk Driving Enforcement Fund, Click-it or Ticket, Drive Sober, Pedestrian Safety, and Distracted Driver.
3. All police officers will be compensated at a rate of \$55.00 for UFRSD Traffic Control, as per a shared services agreement, and at a rate of \$75.00 for Borough work.
