

SIDEBAR AGREEMENT TO THE CNA
BETWEEN THE BOROUGH OF MILLTOWN
AND OPEIU LOCAL # 32
EFFECTIVE JANUARY 1, 2019 TO DECEMBER 31, 2024;

This agreement is entered on this 24 day of July, 2023, between the Borough of Milltown ("Borough") and OPEIU Local #32 ("Union") (collectively "the parties");

WHEREAS, the Borough and the Union are parties to a Collective Negotiations Agreement ("CNA") covering the period January 1, 2019 to December 31, 2024;

WHEREAS, the parties have desired and recognized that there is a need to add a new job title within the CNA; and

WHEREAS, the parties have discussed and agreed to the below listed changes to the CNA;

NOW, THEREFORE and in consideration of the terms and conditions set forth herein, the parties agree to the following amendment of the CNA;

1. Schedule A shall be amended to include the title of "Part Time Principal Account Clerk", "Payroll Clerk", "Water/Sewer Repairer 1" and "Water/Sewer Repairer 2"
2. Schedule C shall be amended to include the salary for the title of "Part Time Principal Clerk", "Payroll Clerk", "Water/Sewer Repairer 1", "Water/Sewer Repairer 2" and an update to salary for "Municipal Court Administrator" as follows:

WHEREAS, the Borough and the Union wish to include the following new job titles within the CNA; and,

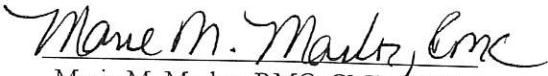
1. PT Principal Account Clerk
