OFFICERS RESPONDED TO THE PARKING LOT OF C TOWER AT PARKVIEW TOWERS FOR A DISPUTE OVER A PARKING SPACE. BOTH PARTIES AT THE SCENE WERE SHOUTING AT EACH OTHER AND OFFICERS AND WERE EXTREMELY UNCOOPERATIVE. THE DRIVER OF THE PARKED VEHICLE, JAMIL JACKSON, CLAIMED THAT HIS VEHICLE WAS STRUCK AS HE PULLED INTO THE PARKING SPACE.
