As per our conversation, the Tiny House Trailer has been listed for sale since last September. Please see photographic evidence below. I've received quite a bit of activity on it. I just really need one committed buyer. The unit is uninhabitable as per the town's request. The waterlines have been cut and sealed for transport and all plumbing has been winterized. I am simply maintaining the plug of electricity at this time, so I may show the unit to prospective buyers. When viewing the marketplace listing, it will show that it was just listed in March, but that is due to marketplace deleting and relisting items monthly. Please reference the last photograph where you will see the correspondence regarding sales dating back to September 21, 2023. I also have documentation of all the correspondence for the months in between should that be necessary. The unit is additionally, listed for sale on craigslist in four different regions within western New Jersey and eastern Pennsylvania. If you would like additional evidence of that, please let me know. I just need to go on my laptop and pull down the listings for you. We were also listed on Tiny House Society, but after receiving a fraudulent payment, I have since withdrawn the site, but can still find the original listing for you as further evidence that we have been trying to sell this unit since last fall. I am requesting an extension from the town, through June 19, 2024 to complete the sales process. I am able to register the unit with DMV if the town prefers, making it allowable on the property as an uninhabited RV, but as that title would take 30 days to secure and serve of no purpose to out of state buyers, I had not pursued that option in favor of simply trying to sell it. Please let me know if my extension request is approved by the town as their last correspondence, referenced dates, fines & court appearances. Kind Regards,
