I arrived first and was pointed to the direction of checkout by customers. I entered through the exit of the building, and heard several people yelling towards each other. Due to multiple voices in the immediate vicinity attempting to overtake another, I utilized verbal constructive authority to be heard by all, and ordered the parties to separate. The (2) parties were identified as David Ginn and Perrin Mosca. Patrolman Saldivia arrived in the area moments after. I first spoke to David, who advised Perrin was in the store not wearing a mask. He insisted Perrin wear one, which led to a verbal dispute in an aisle of the store. While speaking to David, I observed he was also not wearing a mask, and did not for the majority of my time on scene. Other customers in the store also attempted to add their own input regarding current mask mandates and the need to have one on. I then spoke to Perrin, who advised he does not wear a mask due to [REDACTED] exempting him from the mask mandate. He advised he has shopped in the store on previous occasions without wearing a mask, and without issue. On this day, he advised David confronted him about it in one of the store aisles. During the verbal dispute, Perrin advised David also pushed Perrin's shopping cart several feet away from him. He did advise the shopping cart did not make any physical contact with him or anyone else. Perrin stated he then confronted the store manager, identified as James Touw, about the encounter. Patrolman Saldivia and I spoke to James separate from David and Perrin about the store policy for wearing masks. He advised the store follows the current state mandate. James advised he was informed by Perrin he [REDACTED] and did not inquire more due to possible HIPAA violations. James then advised he asked Perrin to pay for his groceries, and exit the store. Both parties advised the dispute was verbal in nature, and no physical contact took place between them. Both parties paid for their respective groceries, and left the business without further incident. No further police action was taken at this time. EM166
