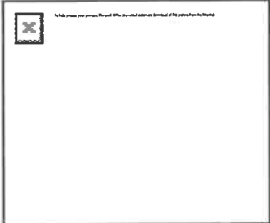

In response to your latest email, dated 8-5-2024, South Brunswick Township Fire District No. 2 provides the following information for clarification, after discussion with our attorney, Richard M. Braslow.

First, we will reiterate that South Brunswick Township Fire District No. 2 does not possess any records other than which has already been provided concerning Franklin Township Fire District No. 4.

As you mention, Section 7 of the Shared Services Agreement between the three South Brunswick Township Fire Districts specifically states that Fire District No. 3 shall be responsible for the administrative details regarding the per diem staff, including payroll. It is further the responsibility of Fire District No. 3 to submit invoices to Fire District No. 1 & No. 2 for the associated costs of the per diem staff. As of the writing of this email, the municipality of South Brunswick Township, which processes the payroll for all three fire districts, has not provided the second quarter payroll invoices. As such, Fire District No. 3 has not provided invoices to Fire District No. 1 or No. 2. Fire District No. 2 does not maintain records of the per diem staff, as again, this is the responsibility of Fire District No. 3, so it is impossible for our district to provide such records. Please contact Fire District No. 3 for these records and any potential discrepancy that you allude to.

Also as you mention, Section 16 of the Shared Services Agreement states that the Fire Chiefs shall make decisions for mutual aid requests outside of South Brunswick Township or Franklin Township Fire District No. 4. This agreement honors the agreement between South Brunswick Township Fire District No. 3 and Franklin Township Fire District No. 4 for coverage of emergency calls. It is understood by all three South Brunswick Fire Districts

that the daytime staff coverage shall respond automatically into Franklin Township Fire District No. 4 when the crew is on duty.

In response to your comment requesting clarification of our interpretation of OPRA, we cannot make it any clearer that South Brunswick Township Fire District No. 2 has provided all records to the requesting party as they pertain to Franklin Township Fire District No. 4. There should be no further question or confusion on this matter as we have met the statutory requirements of OPRA. Records simply cannot be provided if they do not exist.

Lastly, we request that any future correspondence regarding OPRA requests as they pertain to Franklin Township Fire District No. 4 should be directed to our attorney, Richard M. Braslow. He can be reached via email at braslowesq6@gmail.com. Mr. Braslow will respond to any future OPRA requests on behalf of South Brunswick Township Fire District No. 2.

Dear Mr. Smith,

Thank you for your response (August 5, 2024) to my Open Public Records Act (OPRA) request dated July 30, 2024.

While I acknowledge your statement that South Brunswick Township Fire District #2 (SBFD2) does not have the requested invoices for services provided to SBFD3, I would like to clarify a potential discrepancy based on the shared services agreement you previously provided (attached).

Section 7 of the agreement entered into by SBFD2, dated March 26, 2024, outlines the process for billing per-diem staff costs to all three districts. To ensure transparency and accurate financial records, I would appreciate it if you could confirm whether SBFD2 maintains any records related to per-diem staffing, even if not directly invoiced to FTFD4.

Furthermore, Section 16 of the same agreement references decision-making by fire chiefs regarding mutual aid requests outside of South Brunswick Township or Franklin Township Fire District 4. This section appears to suggest a potential role for SBFD2 in such situations.

Therefore, I would be grateful if you could clarify SBFD2's involvement, if any, in mutual aid responses related to FTFD4.

Finally, I understand your position that SBFD2 has no formal obligation to provide fire protection services to FTFD4.

However, under OPRA, public entities are generally required to provide access to records regardless of the specific contractual relationship between the requesting party and the governing body.

Therefore, I would appreciate Mr. Braslow's assistance in clarifying SBFD2's interpretation of OPRA as it relates to my request for records related to per-diem staffing and potential involvement in mutual aid responses for FTFD4.

Thank you for your time and attention to this matter.

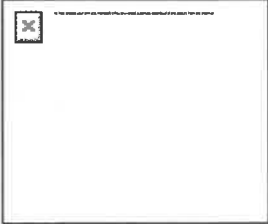

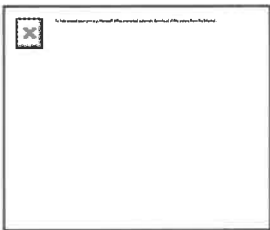
