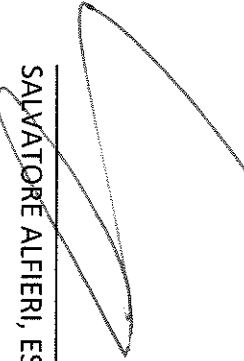

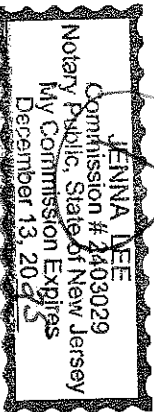

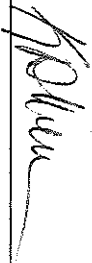

Said premises are known as Block 300, Lot 58 and located within the R-80 (Residential) zoning district.

The application is for Use Variance and Preliminary and Final Site Plan approval to demolish the existing dwelling and to construct a 13,337 s.f. house of worship. Houses of worship are a conditional use and a N.J.S.A. 40:55D-70(d)(3) variance is required because all ordinance conditions have not been met. More specifically, the following variances are required for minimum lot frontage (existing condition: 250 ft., required and 59.71 ft. existing), minimum lot width (existing condition: 250 ft., required and 104.15 ft. existing) height of accessory building (existing condition: 15 ft., maximum and 18 ft. existing) and side yard setback of accessory building (existing condition: 25 ft., required and 3.8 ft. existing). Further, the accessory building is located in the side yard and the proposed parking lot is located within the front and side yard, which is not permitted. The proposed plan does not provide a thirty-five (35) foot landscaped buffer, as required for all sites within a residential zoning district. The proposed fence is six (6) feet tall and opaque, whereas the Township requires any fence erected in any zone to be open fence and not exceed three (3) feet. The maximum slope for the lawn is twenty-five percent (25%) whereas a maximum slope of thirty-three percent (33%) is being proposed. The proposed off-street parking spaces are 9 ft. by 18 ft., whereas each off-street parking space shall not be less than 10 ft. by 20 ft. The parking spaces are located in excess of one hundred fifty (150) feet of the building, whereas such spaces should be located within one hundred fifty (150) feet of the building that such facility is required to serve.
