Hi again, Douglas:

Thank you for sending the initial write-up. It reads well. I just wanted to mention that in Volume 1 in The Papers of Martin Luther King Jr. Pgs 87-90, there is a chronology which lists King as an 'associate and assistant pastor at Ebenezer' Baptist during the summers of '48, '49 and '50, and also lists sermons he delivered there. That might help to eliminate some of the time he could have been in Camden. The speeding incident on June 16th, 1950, in Delaware, is recorded as well. June 12th - 19th, 1950 was an action-packed week for King, to say the least.

Thanks again, and yes, I hope you'll keep me in the loop if the report changes or something new pops up.

King and Walter McCall were best friends at Crozer, and they often went over to the Camden area, simply because McCall had family there. King's sister, Christine, was also at Teachers College in NYC at that time, 2 hours away. In Christine's memoir, *Through it All*, she describes a moment when she and 'Martin' are driving together 'down' to their brother A.D.'s wedding, which occurred on June 17th, 1950, 5 days after the Maple Shade incident was filed.

King lived in Crozer's main seminary building during his three years there. Now the building is the Crozer-Chester Medical Center. When I visited, many of the office workers there told me that King's dorm room is now an office, numbered 217 on the second floor.

Crozer classes typically finished in May, so he had plenty of time to stay, or 'crash' with McCall at the rowhouse. There is no evidence that I have found, however, that Camden was his primary residence. Did he stay there for perhaps 3-4 weeks at a time? Possibly. He had reasons to. For starters, he could have preached at several nearby Baptist churches. He also frequently preached at Calvary Baptist church in Chester, and greatly admired J. Pius Barbour.

Unfortunately, the only person who could indeed give a definitive answer on this would have to be his sister, Christine, since she is on record as being with King five days after Maple Shade. She is very difficult to reach, however.

There is just too much evidence from old interviews by King's Crozer classmates, too many stories that are 'dorm-specific'. His primary residence was the dorm, but I have no doubt that he stayed for extended periods of time with Walter in the summer. They went everywhere together. It would have been difficult to commute daily from that Camden home to the Crozer campus in 1950. Even now, in 2015, it is a 35 minute trip by car.

Hi--Sorry for my tardiness: yesterday I was following the S.Ct. arguments & getting press calls about Baltimore as well as being in book-writing mode.

Do you need a formal letter from me, or can we have a phone conversation?

While I'm *very* impressed with Patrick Duff's energy & dedication on this, I think the bottom line is quite clear & certain: Doc's best friend, Walter McCall, was related to the people at that home in Camden, and Doc certainly *stayed* there as a guest of McCall on however many nights, but all the interviewing of King classmates at Crozer that took place when they were still alive indicates pretty dispositively that during academic semesters Doc was living at Crozer, not in Camden. As the Maple Shade incident indicates, outside of the academic year calendar Doc may indeed have been in Camden some. There's a younger scholar in Washington state, Patrick Parr, who is more on top of all this than anyone else alive! Mr. Branch:

We recently received a preliminary application for a house at 753 Walnut Street in Camden, New Jersey. According to information prepared by the applicant, Martin Luther King, Jr. shared a room in the house with Howard McCall during a portion of his attendance at Crozer Seminary. The house was owned by McCall's cousin. The applicant argues that the significance of the house is increased because it was King's place of residence at the time of the incident at Mary's, a tavern in Maple Shade, Burlington County, in which King and several others were refused service. He also argues that this incident may have been the genesis of King's efforts for social and racial justice. Our office is presently evaluating whether the house meets any of the criteria for National Register eligibility.

I know that the incident at Mary's was not included in your three-volume biography of Dr. King. Are we correct in inferring that omission is due to your carefully considered opinion that the incident was not important in King's later life?

Thank you for your outstanding books. I look forward to hearing from you.
