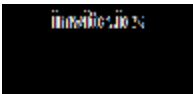

I am under the impression that the Land Use Board was expecting the Township Committee to address the issue through the rental ordinance. I am not sure if there is a zoning violation occurring as the laws are currently written. I will defer to Gordon on this matter.

From what I understand, the construction official and fire official both went out to the property and had determined there was no change of use. Gordon sent them a cease and desist letter telling them to stop any commercial activity. Dave Haaf is the housing officer and he recently had the owner fill out a rental registration form.

Dave's suggestion is that we pass an entirely new ordinance directly addressing short term rentals rather than amending the current rental ordinance. He believes they are two separate issues and the short term rentals are almost more of a mercantile license. He provided documentation from Ocean City to show the forms they use.
