Note

On Wednesday, August 14, 2019 at approximately 1951 hours, I was dispatched to 811 Laurel Rd., Lindenwold, NJ for a possible removal. Central Communication advised me that the mother of Brooklynn M. Miller, called and advised that the female was at the aforementioned address and had multiple outstanding warrants.

Upon arrival I observed a white female, later identified as Brooklynn M. Miller wearing a black sports bra, black pants, with her hair up on the back deck of the residence. As I began to walk towards the residence the female entered the residence. I continued to the residence and asked residents if Brooklynn Miller was on location, they advised that she was and invited me inside. As I entered the residence I was advised that the female ran out the front door.

I spoke to the property manager (Mandi L. Barber) who informed me that Brooklynn was supposed to be a new move in but was declined after failing the initial drug test. Brooklynn was supposed to be waiting for her mother to arrive to pick her back up.

While checking the area for Brooklynn Central advised me that she had multiple outstanding warrants. Brooklynn had a warrant out of Cherry Hill Municipal Court for \$1500 (Warrant # S-2018-002331), and a warrant out Gloucester Township Municipal Court for \$1500.00 (Warrant # W-2019-000921). I later located Brooklynn in front of Lena's Water (615 Laurel Rd., Lindenwold, NJ).

While attempting to talk to Brooklyn she became uncooperative and would not answer any of my questions. She was advised that she was under arrest, she then stated that she needed to go to the hospital for [REDACTED] because she was feeling [REDACTED]. She was transported to Jefferson Hospital Stratford, NJ for medical treatment. She was later released on her recognizance on both warrants.

Sumitrabe had nothing further to report about the burglary and reported nothing else missing. I went out the area of the burglary and attempted to speak with a couple neighboring residences. I knocked on 911A Laurel Rd which is next to the victims property and 643 5th Ave which is behind the victims property. I received no answer at either location. I checked the cameras at the Bible Baptist Church of Christ and they appeared to be angled in a way that only covers their property and would not capture anyone near where the burglary occurred. I contacted Center Stage Entertainment and left a message for someone to return my call in reference to their cameras. I examined the head flashlight that was found on scene and it could possibly have some contact DNA on the band where it straps to your head. I requested that Det. Sherrer send it to the NJSP Crime Lab for DNA analysis. 07/06/18 I spoke with Andrew Kita from Center Stage Entertainment and he advised that they do not have any cameras that face Laurel Rd. His cameras face the back parking lot and side entrance. 07/25/18 I went to Sgt. Scrap located at 610 Rt.130 Gloucester City NJ in an attempt to inquire about the copper theft. Sgt. Scrap is a mobile scrap metal services business that gives customers money for trading in various types of metals. Upon arrival I met with employee Samantha and I explained to her why I was there and that I was looking for any kind of large amounts of copper being scraped for money after the date of the burglary. Samantha found one transaction that was a large amount however the type of copper that was scraped appeared to be from an industrial business and not a residential home. I gave Samantha my information and advised to contact me if anyone comes in with a large amount of residential copper. I checked the Rapid online pawn shop data base and received in excess of 100 hits of copper which makes it difficult to research any of them.

On 07/01/2018 at 1558hrs, Lindenwold Police were dispatched to a found breaking and entering at 811 Laurel Rd in Lindenwold. The caller advised that someone broke into the house and stole the copper piping. When I arrived on scene, I spoke to the caller, identified as Sumitrabe Amin. Ms. Amin stated that she and her business partner, Jayesh Parikh, own the house and had the house up for sale. The house was vacant at this time. When she arrived today to show a buyer the house, she entered the house and noticed the damage done to the basement.

When she walked through the bottom level further, she noticed the walls damaged and the copper piping missing from the walls and the ceiling. She continued to say that water was draining from the pipes. The water was shut off by Ms. Amin prior to police arriving. Ms. Amin explained that she was at the house last on 06/26/2018 at 1500hrs. The house was untouched and in good condition at this time.

I investigated the perimeter of the house and found the window to the basement on the north side, closest to the rear of the house, was broken into. This appeared to be where the unknown suspect(s) entered the residence. There were no noticeable finger prints in the area of the window. I then proceeded toward the basement and found damage throughout the entire basement. There were several holes cut out in the wall. The floor was wet and the copper piping was missing for the water lines. Water was noticeably dripping from the pipes cut near the water heater located in the basement. I checked the window that was used to gain entry to the house and discovered the broken window leaning on the wall. I checked it for viable fingerprints, but none were found. I continued to inspect the house and found a head flashlight near the window in the basement on the south side of the house. I was advised by Ms. Amin that it was not her flashlight or anyone else's associated with the house.

During the time I was investigating the crime scene, Jayesh arrived on scene. He confirmed that he and Ms. Amin owned the house and were trying to sell it. Jayesh advised that he was last at the house on 06/28/2018 at approximately 1430hrs. He was there when the lawn care company was there cutting the grass. He stated he was there for him and the house was untouched at this time.

When checking for more damage to the residence, I noticed an alarm system on the wall. Ms. Amin advised that the system was not active at this time. There was no further damage discovered in the house at this time. The house and the damage done to the house was photographed and entered in as evidence. The head flashlight was collected and entered in as evidence as well.

Ms. Amin and Jayesh evaluated the copper piping missing from the house to be worth around \$5,000. They examined the damage and estimated it to be almost \$10,000. I advised both parties to contact police if they had any further information about the incident.

I checked the surrounding area for any cameras that may have caught the incident. I noticed cameras on The Bible Baptist Church of Christ (1000 Laurel Rd, Lindenwold, NJ) and the business known as Center Stage Entertainment (902 Laurel Rd, Lindenwold, NJ). I was unable to view camera footage due to both places being closed.
