Investigative Report

On the above date and time, PO Dispoto and I responded to a shoplifting incident at 100 Farm View, Wegman's. On location we met with the complainant, Wegman's Security Officer Christina Nates, who informed us that she had a shoplifter, Julie Allen, in her office who stole approximately \$109.91 worth of merchandise. (See receipt of unpaid items in case folder) Nates stated she observed Allen falsely scan the merchandise in her mobile app and proceed to the check out registers. Allen then holds up the main screen of the app to the register and appears to scan the incorrect checkout image on her phone. She then proceeds to exit with the unpaid items in a reusable shopping bag inside a shopping cart. Security then approached her and requested she go back into the security office with her in regards to the stolen goods, to which she complied.

We then entered the office and spoke with Allen. I read her Miranda Rights and she stated she understood. She then admitted to stealing the merchandise in the way security had described. Allen was told to empty her pockets, which she did. She was asked if she had any weapons, knives, or needles on her person, which she denied. Security issued Allen a Wegman's Trespass Notice Form banning her from store property for two years, which she completed and sign. Allen was then placed under arrest and rear-cuffed by PO Dispoto. He frisked her outer garment with the backs of his hands due to her being a female with negative results. She was then escorted and placed inside patrol vehicle MV363. A check of that vehicle was conducted at the start of the shift, prior to placing her inside, and after she was released. PO Dispoto then transported her to MPD HQ and I followed behind. All stolen merchandise remained in the store and Nates stated she would forward surveillance video to MPD DB.

At HQ, Allen was lodged in Cell #2. Female Police Matron McGee conducted a full search of Allen's person with negative results. She was then processed and released under her own recognizance with a mandatory court appearance of 5/11/2022 at 4PM at Pascack Joint Municipal Court. She was charged with criminal complaint: 2C:20-11b(1) Shoplifting less than \$200 on Summons 0236-S2022-000045. A disorderly persons offense.
