On the above date and time, I followed up on a complaint that was made by the Borough Of Monmouth Beach. I was previously contacted via email by Borough Administrator Villane who reported that the borough received complaints regarding the shrubs and plants located at the corner of Ellis Court and Patten Ave particularly at 1 Ellis Court in violation of the sight line / triangulation at intersection.

Borough Code Enforcement Official Louis Tocci reportedly reached out on numerous occasions to the property owner, Joseph Nardone, regarding the complaint and violation. He has yet to receive a call back or contact from Nardone.

The plants and shrubs are in violation and are well above the allowed 30 inches above the curb within the triangulation.

A violation notice was generated and sent out to Nardone advising him to rectify the issue.
