Attached is the 2024 Internal Affairs Summary, in response to paragraph one.

Paragraph two and three:

If there is a specific, identifiable record you wish to access, please provide additional information so that we can identify the record without the need for research, search all of our records, and limited in scope and not a request for "all" records and as to not create an undue burden on our agency.

The courts have ruled:

"Nor does OPRA "authorize a party to make a blanket request for every document" a public agency has on file. See *Gannett, supra*, 379 N.J.Super. at 213, 877 A.2d 330 . Rather, a party requesting access to a public record under OPRA must specifically describe the document sought. *Ibid.*; see also *MAG Entm't, supra*, 375 N.J.Super. at 546-49, 868 A.2d 1067 . OPRA operates to make identifiable government records "readily accessible for inspection, copying, or examination." N.J.S.A. 47:1A-1. As such, a proper request under OPRA must identify with reasonable clarity those documents that are desired, and a party cannot satisfy this requirement by simply requesting *all* of an agency's documents. OPRA does not authorize unbridled searches of an agency's property. See *Bent v. Stafford Police Department*, 381 N.J.Super. 30, 37 (App. Div. 2005)."

INTERNAL AFFAIRS

The Neptune Township Police Department Internal Affairs Unit accepts, reviews, and responds to all complaints against police officers received from the public or from superior officers within the organization. Citizen complaints may be made via any method including, but not limited to: in person, by telephone, fax, internet, or through the mail. These include anonymous complaints, complaints from third party witnesses, juveniles and complaints from parties not directly involved in the incident from which an allegation arises. All allegations are carried to their logical conclusion by experienced and trained investigators.

In any given year officers of the Neptune Township Police Department are involved in tens of thousands of citizen contacts. Many are routine and many involve critical situations. The Internal Affairs Unit is tasked with handling complaints from the public regarding officer conduct, as well as rare allegations of criminal conduct by department members.

The investigative process assesses the propriety of all on or off duty conduct during the incident in which the alleged misconduct occurred. If during the course of an investigation there is an indication that misconduct occurred other than that alleged, the investigator examines the additional potential misconduct to its logical conclusion.

The following penalties may be assessed against any member or employee of the Neptune Township Police Department as a result of disciplinary action:

Oral Reprimand
Written Reprimand
Suspension
Demotion
Dismissal

INTERNAL AFFAIRS

All complaints are categorized based on the alleged offense. Upon the completion of the investigation, the investigator will reach a conclusion based upon the facts developed in their investigation which will fall into one of the following five dispositions:

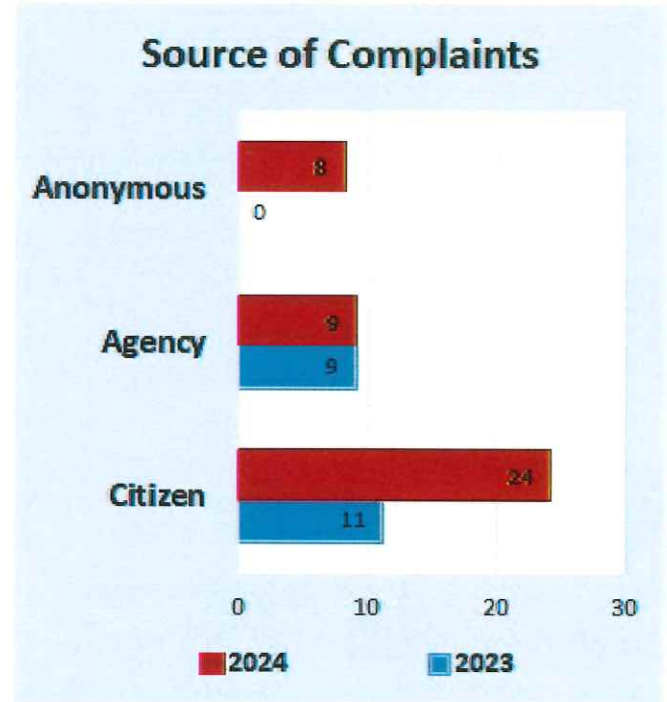
Exonerated: A preponderance of the evidence shows the alleged conduct did occur, but did not violate any law; regulation; directive, guideline, policy, or procedure issued by the Attorney General or County Prosecutor; agency protocol; standard operating procedure; rule; or training.

Sustained: A preponderance of the evidence shows an officer violated any law; regulation; directive, guideline, policy, or procedure issued by the Attorney General or County Prosecutor; agency protocol; standard operating procedure; rule; or training.

Not Sustained: The investigation failed to disclose sufficient evidence to clearly prove or disprove the allegation.

Unfounded: A preponderance of the evidence shows that the alleged conduct did not occur.

Administratively Closed: This disposition is used for extraordinary circumstances that isn't defined by any of the other four dispositions. (e.g., employee passes away.)

NOTICE OF SPECIAL SERVICE CHARGE

The Township of Neptune is in receipt of your OPRA requested dated 6/26/25.

The body worn camera(s) footage you requested may contain one or more of the following that must be redacted: (a) the image of a victim of a criminal offense; (b) the image of a child; (c) was made in a residential premise (e.g., home, apartment, college dormitory room, hotel/motel room, etc.), a school or youth facility, a healthcare facility or medical office, a substance abuse or mental health treatment facility, or a place of worship; (d) a conversation with a person whose request to de-activate the BWC was declined; (e) a special operations event or execution or an arrest and/or search warrant where confidential tactical information may have been recorded; (f) the image of an undercover officer or confidential informant; (g) the screen of a police computer monitor that is displaying confidential personal or law enforcement sensitive information; or (h) any other confidential personal or medical information.

In accordance with N.J.S.A. 47:1A-5 the Neptune Township Police Department Records Bureau reserves the right to charge a Special Service Charge for the following: *"Whenever the nature, manner of collation of volume of government record embodied in the form of printed matter to be inspected, examined or copied pursuant to this section is such that the record cannot be reproduced by ordinary document copying equipment in the ordinary business size or involves an extraordinary expenditure of time and effort to accommodate the request, the public agency may charge, in addition to the actual cost of duplicating the record, a special service charge that shall be reasonable and based upon the actual direct cost of providing the copy or copies...."* The requestor shall have the opportunity to review and object to the charge prior to it being incurred. As such, a detailed estimate is provided below:

The production of the BWC records in this request will require an estimated 29 hours to complete. The current lowest hourly rate for the department's employee with the training to review and redact the requested BWC footage is \$ 39.35 per hour; thus, a total clerical cost of \$ \$1,141.15. If you agree to the said cost, payment must be made in full before the township proceeds with your request. **Please provide written confirmation** of your acceptance or rejection of the Special Service Charge and date of anticipated payment, within 10 days, or we will deem this OPRA Request to be closed.

COMMERCIAL LEASE AGREEMENT

The Landlord and Tenant agree to Lease the Rental Space designated herein for the Term and at the Rent stated herein. The words "Landlord" and "Tenant" include all Landlords and Tenants under this Lease.

LANDLORD: Pride Properties, Inc.

TENANT: Bennett's Auto Recovery
c/o Gary Bennett (also any other entity
created by Gary Bennett or Eve Bennett
that operates in the towing industry)

RENTAL SPACE: Block 414, Lot 9, more commonly referred to as 601 Memorial Drive, Neptune, NJ 07753, which consists of 700 square foot building and 320 square foot detached garage(+/- sq.'), referred to herein as the "premises."

DATE OF LEASE: July 1, 2024

TERM: Three (3) Years beginning July 1, 2024 and ending June 31, 2027

BEGINNING: July 1, 2024

ENDING: June 30, 2027

The Parties agree that the Tenant shall have a one-time option to extend this Lease Agreement. Both Parties must agree to the Lease extension in writing and the extension must be agreed to six (6) month prior to the End Date as defined in this Lease Agreement. Should either Party choose not to extend the Lease as per the option, then the Lease shall terminate on the designated end date.

SECURITY DEPOSIT: (2 MONTH BASE RENT)—On July 1, 2024, Tenant shall fund so that the Security Deposit is two month's rent. The tenant shall fund the security deposit whenever there is a shortage when yearly increases occur.

BROKER: The Landlord and the Tenant recognize that neither has used the services of a Broker to bring about this Lease, and that there are no commissions due and owing to any realtor or broker. In the event it is determined that a commission is owned to any broker or realtor, the party who acquired such realtor or broker shall be responsible for any such commissions, and the parties shall mutually indemnify and hold the other harmless for same.

LIABILITY INSURANCE: Tenant shall maintain a minimum amount of property, casualty and personal injury insurance for each person injured: \$1,000,000.00; aggregate for personal injury for any one accident \$1,000,000.00; and for property damage \$1,000,000.00. Tenant shall also carry insurance coverage for tenant's personal property in the amounts to be determined solely by tenant. Tenant shall also maintain any other insurance, including but not limited to business continuity insurance, workmen's compensation and general automobile insurance, that Tenant shall be required to maintain by law for Tenant to operate its business. Tenant's personal property or business insurance is not covered under Landlord's insurance policy, and Tenant shall have no right to demand payment for personal property by Landlord.

USE OF RENTAL SPACE: Towing, Auto Recovery, Storage. No demolition and no auto repairs services are a permitted use of the property.

MUNICIPAL REAL ESTATE TAXES: The Base Rent includes Municipal Real Estate Taxes based on the Real Estate Taxes which were due for calendar year 2023, with 2023 being known herein as the "base year." If in any calendar year of this lease agreement, including year 2023, the municipal taxes increase, the Tenant shall also be responsible to pay as Additional Rent all of the amount by which the annual municipal tax exceeds the annual tax due for the base year. Once the tax has been published by the municipality, the Tenants portion of the additional taxes shall be paid as additional rent prior to the end of the then-existing calendar year, but in equal installments beginning on the first day of the month immediately following the month when the taxes are published by the municipality. The

equal installments shall be the amount of the Tenant's portion of the additional taxes divided by the number of months remaining in the current calendar year. (By way of example, if the new municipal taxes are published in July and the total tax increase is \$200.00, the additional monthly rent for the tax increase shall be the Tenant's total portion of the tax increase divided by 5, since there would be five full months remaining in the calendar year, so the example equation is: $100\% \times \$200.00 \div 5 = \$40/\text{month}$.)

TENANT'S UTILITIES: Tenant shall be responsible to pay for all public utilities, including water, sewer, electric, gas, phone and cable, which Tenant uses for the premises. If any such utility bill comes directly to the Landlord, the Tenant shall have thirty (30) days to make payments to Landlord, which shall be considered additional rent. For all utilities that Tenant may obtain an account directly from the public utility, the Tenant shall obtain the same and pay such utilities directly to the public utility. The premises shall be heated in the winter to prevent freezing pipes.

BASE RENT: The Base Rent, which is exclusive of Additional Rent to be paid by Tenant as defined herein, is as follows:

Base Rent for July 1, 2024 - June 30, 2025:

\$41,280.00, payable in equal monthly installments of \$3,440.00 per month

Base Rent for July 1, 2025 - June 30, 2026:

\$42,600.00, payable in equal monthly installments of \$3,550.00 per month

Base Rent for July 1, 2026 - June 30, 2027:

\$43,800.00, payable in equal monthly installments of \$3,650.00 per month

POSSESSION AND USE: If the Tenant takes possession of the space prior to the beginning of the term indicated on Page 1, Tenant shall pay the Landlord rent and proportionate expenses, calculated on a per diem basis, with the first rent payment due. The Landlord shall give possession of the Rental Space to the Tenant for the Term. The Tenant shall take possession of and use the Rental Space for the purpose stated herein. The Tenant may not use the Rental Space for any other purpose without written consent of the Landlord. The Landlord and Tenant have agreed that the tenant can occupy the premises before the start of the lease term at a cost of \$70.00 per day and the access is limited strictly to the yards.

The Tenant shall not allow the Rental Space to be used for more than one (1) business, or for any unlawful or hazardous purpose. Tenant shall be responsible for removing all waste that may be generated in connection with the Tenant's use, in accordance with applicable, local, county state and federal laws, ordinances and regulations. The Tenant is satisfied that the Rental Space is suitable for the use stated herein. The Tenant shall obtain any and all required governmental approvals and inspections, as may be required for Tenant to operate its business. The Tenant shall obtain all other certificate(s) or permits required to authorize the Tenant to use the Rental Space for the permitted use. The Tenant shall comply with all rules, regulations and, if the building is a condominium, with By-Laws and the Master Deed established by the building association and trustees. Tenant shall make immediate application for any governmental permits it may need to operate its business and promptly comply with all future governmental requirements for it to operate its business.

The Tenant shall not use the Rental Space in any manner that results in (1) an increase in the rate of fire or liability insurance of the Landlord or any other tenant, (2) cancellation of any fire or liability insurance policy on the building or rental space or (3) violate the environmental integrity of the building. The Tenant shall comply with all requirements of the insurance companies insuring the Rental Space. The Tenant shall not abandon the Rental Space during the Term of this Lease or permit it to become vacant for extended periods of more than one (1) week without notice to and approval by the Landlord.

DELAY IN GIVING POSSESSION: This paragraph applies if (a) the Landlord cannot give possession of the Rental Space to the Tenant on the beginning date and (b) the reason for the delay is not the Landlord's fault. The Landlord shall not be held liable for the delay. The Landlord shall then have 60 days in which to give possession. If possession
