

PLEASE READ CAREFULLY

1. PLEA OF NOT GUILTY

If you wish to plead not guilty to the offense in this Complaint-Summons, you must notify the court, whose address and telephone number are shown below, at least 5 days prior to the court date listed on the front of this Complaint-Summons. Please confirm with the court your contact information including your email address and telephone number. If you fail to notify the court, it may be necessary for you to make additional court appearances.

2. PAYMENT AND GUILTY PLEA

If you wish to plead guilty and give up your rights to have an attorney and a trial, you may do so provided "Court Appearance Required" has not been checked on the reverse side and the charge is payable. Go to www.NJMCdirect.com to determine if the offense is payable and the amount of the penalty. You may plead guilty and pay the penalty online through that website. You may also plead guilty and pay the penalty at the court or you may mail this Complaint-Summons, together with payment in the amount of the penalty, to the court at the address indicated below. Payment must be made prior to the court date displayed on the front of this Complaint-Summons.

Payments by mail are to be made by check or money order payable to this Municipal Court. Do not send cash. Please print the Complaint-Summons number on the front of the check or money order. If payment received by the court after your court date, you may be assessed additional penalties. A receipt will be sent to you only if your payment is accompanied by a self-addressed, stamped envelope.

If you wish to plead guilty, but are unable to pay your fines and costs in full, go to www.NJMCdirect.com or contact the court for more information.

3. COURT APPEARANCE REQUIRED

If the offense charged on the reverse is not payable, or if "Court Appearance Required" is checked (see check box on reverse side), you must appear on the date and time indicated, even if you wish to plead guilty. The court may schedule you to appear in person or by video. You may also be able to resolve your matter online. Please go to www.NJMCdirect.com or call the court for more information.

APPEARANCE, GUILTY PLEA AND WAIVER

By paying the fine, I am agreeing to plead guilty. I give up my rights to an attorney, to apply for a public defender, and to remain silent. I also give up my right to be present at trial and to cross-examine any witnesses. I admit that I committed the offense charged, plead guilty and make payment of the prescribed penalty. I understand that, if the offense charged is a traffic matter, a record of this conviction will be sent to the New Jersey Motor Vehicle Commission and, if my license was not issued by New Jersey, to the motor vehicle agency of the state that issued my driver's license.

If you fail to appear in response to this Complaint-Summons or to pay the prescribed penalty, additional penalties may result and/or a warrant may be issued for your arrest. If you have been charged with a parking offense, your failure to appear or pay the prescribed penalty shall be considered an admission of liability and a default judgment may be entered against the owner of the vehicle.
