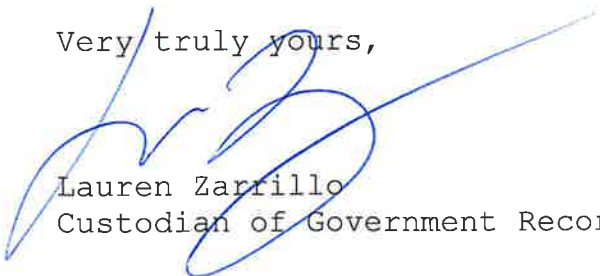
This letter constitutes the response of the Office of the Governor to the above-referenced OPRA request, which states in pertinent part:
