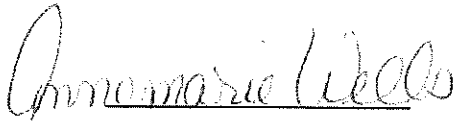

WHEREAS, in accordance with N.J.S.A. 40A:9-141, and pursuant to Resolution Nos. 2020-45 and 023-151, Kathy Sireci was appointed to a four-year term as Certified Tax Collector of the Township of Rochelle Park, effective January 1, 2021; and

WHEREAS, said appointment is due to expire on December 31, 2024; and

WHEREAS, the Mayor and Township Committee wish to reappoint Kathy Sireci in accordance with N.J.S.A. 40A:9-145.7, which regulates the terms for reappointment and N.J.S.A. 40A:9-145.8, which provides that any person who is reappointed as Tax Collector shall have acquired tenure and shall hold his or her office during good behavior, and compliance with continuing education requirements.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Township Committee of the Township of Rochelle Park in the County of Bergen, State of New Jersey, that Kathy Sireci be reappointed as Certified Tax Collector, effective January 1, 2025, and upon this reappointment attained tenure pursuant to N.J.S.A. 40A:9-145.8

BE IT FURTHER RESOLVED that the Tax Collector shall be paid in accordance with the Township's salary ordinance.

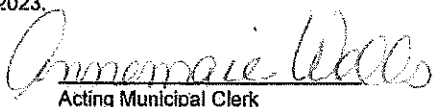

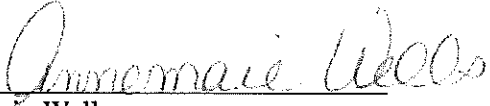
WHEREAS, the State of New Jersey requires that each municipality appoint a Certified Tax Collector pursuant to N.J.S.A. 40A:9-141; and

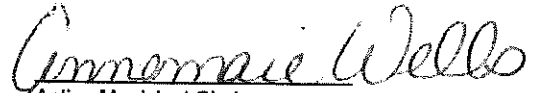

WHEREAS, the Township Administrator has reviewed this request and agrees that the position should, in fact, be converted to a full-time position; and

WHEREAS, KATHY SIRECI, has been serving in that position for a period of time and has performed the duties and obligations of those positions in an exemplary manner receiving praise from the residents and her department head; and

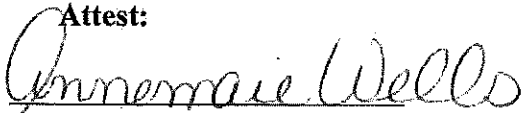

3. The salary for this position shall be \$106,605.00 per year together with all other benefits of full-time employment within this Municipality,
4. This resolution shall take effect on January 3, 2023

WHEREAS, Roy Riggitano, the Chief Financial Officer for the Township of Rochelle Park has also served as Tax Collector for a substantial period of time; and

WHEREAS, Roy Riggitano has received a salary for that position in the amount of \$10,000.00 per year; and

WHEREAS, he has now advised the Township Administrator that he is prepared to resign from that position as of February 1, 2020; and

WHEREAS, Kathy Sireci, of Hasbrouck Heights, New Jersey has served in the position as Deputy Tax Collector and currently holds that position; and

WHEREAS, Kathy Sireci possesses all required certifications and licenses for this position; and

WHEREAS, the Township Administrator has recommended that Kathy Sireci be appointed to the position as Tax Collector for the Township of Rochelle Park to be effective as of February 1, 2020.

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Rochelle Park, County of Bergen and State of New Jersey as follows:

1. Kathy Sireci of Hasbrouck Heights, New Jersey be and is hereby appointed to the position of Tax Collector for the Township of Rochelle Park.

2. This appointment shall be effective as of February 1, 2020 and shall continue for the unexpired term of the previous Tax Collector, Roy Riggitano at which time she shall be eligible for reappointment for a full four (4) year term.
3. The compensation for this position shall be \$10,000.00 per year which shall be prorated for the year 2020.
4. The aforesaid appointment is being made in accordance with the provisions of N.J.S.A. 40A:9-141 and N.J.S.A. 40A:9-142.

NOW THEREFORE BE IT FURTHER RESOLVED that the Township Clerk be and she is hereby authorized and directed to forward certified copies of the within resolution to Roy Riggitano, Kathy Sireci, the Personnel Department and the Township Auditor.
