At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing a Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819 Trenton, New Jersey 08625, by email at grc@dca.state.nj.us or at their web site at www.state.nj.us/grc. The Council can also answer other questions about the law. All questions regarding complaints filed in the Superior Court should be directed to the County Clerk in your county.

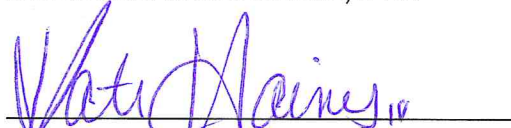

Resolution No. 2021-

RESOLUTION AUTHORIZING THE APPOINTMENT OF A PART TIME SECRETARY

WHEREAS, the Board of Fire Commissioners of Fire District No. 1, Township of Brick, County of Ocean, State of New Jersey, has the authority to create paid positions to assist in its administration; and

WHEREAS, the Board has created the position of Part Time Secretary pursuant to and in accordance with N.J.S.A. 40A:14-81.1 and has authorized compensation for said position; and

WHEREAS, the position of Part Time Secretary has been vacant since January 1, 2021; and

WHEREAS, the Board has noticed said vacancy and advertised for the position; and

WHEREAS, the Board has considered all resumes received in response to said advertisement; and

WHEREAS, the Board finds that the position of Part Time Secretary is necessary and in the best interest of the District.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners of Fire District No. 1, Township of Brick, County of Ocean, State of New Jersey, that it appoint and employ Ellen Reilly Privett to the position of Part Time Secretary effective June 14, 2021; and

BE IT FURTHER RESOLVED, that the appointee/employee be hired at a salary of nineteen dollars (\$19.00) per hour, not to exceed twenty-five (25) hours per week; and

BE IT FURTHER RESOLVED, that the within Resolution shall be effective immediately upon passage; and

BE IT FURTHER RESOLVED, that any resolution or part of a resolution inconsistent herewith is hereby repealed or otherwise revoked; and

BE IT FURTHER RESOLVED, that if any section, paragraph, sentence, clause or phrase in this Resolution is for any reason held or determined to be unconstitutional or invalid, same shall not affect the remainder of this Resolution; and

BE IT FURTHER RESOLVED, that notwithstanding anything set forth herein to the contrary, the Board shall be permitted to amend, modify, repeal or otherwise act as to those topics which are the subject of this Resolution provided said acts are consistent with public policy, Board bylaws, township ordinances, local, state and federal laws and rules and regulations promulgated thereunder; and

BE IT FURTHER RESOLVED, that an original signed, conformed and compared copy of this Resolution be accessible and maintained as an official Board record pursuant to and in accordance with the "Open Public Records Act"; N.J.S.A. 47:1A-1, *et seq.* and the "Destruction of

Public Records Law (1953)"; N.J.S.A. 47:3-8.1, *et seq.* as set forth by the State of New Jersey Municipal Agency Record Retention Schedule promulgated by the Division of Archives and Record Management.
