

Explanation: This resolution authorizes the execution of a professional service contract with Michael Wittenberg, Esq., for legal services for Alternate Prosecutor for the period ending December 31, 2023.

WHEREAS, the Township of Springfield (the "Township"), a public body corporate and politic of the State of New Jersey, has a need for legal services for Alternate Prosecutor (the "Services"); and

WHEREAS, the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq. specifically N.J.S.A. 40A:11-5 permits the award for professional service contract without public advertisement for bids and bidding therefore as would otherwise would be required by N.J.S.A. 40A:11-4; and

WHEREAS, Michael Wittenberg, Esq., has completed and submitted a Business Entity Disclosure Certification which certifies, pursuant to N.J.S.A. 19:44A-20.8 that he has not made a contribution that would bar the award of this contract pursuant to N.J.S.A. 19:44A-20.1 et seq.; and

WHEREAS, the anticipated term of this Contract is one (1) year; and

WHEREAS, the Local Public Contracts Law requires that this Resolution and the contracts authorized hereby be available for public inspection and that notice of such award be published.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Springfield hereby authorizes the Mayor to enter into a Contract with Michael Wittenberg, Esq.; and

Section 1. The aforementioned recitals are incorporated herein as though fully set forth at length.

Section 2. The Township hereby awards a contract for the Services to Michael Wittenberg, Esq., in an amount not to exceed \$4,000.00, for a period not to exceed one year, and to expire on December 31, 2023. The sum to be paid per session is \$200.00.

Section 3. The Chief Financial Officer hereby certifies that the account number to be charged is 3-01-20-155-000-201, pending the adoption of the 2023 Budget.

Section 4. A copy of this Resolution shall be available for public inspection at the offices of the Township Clerk.

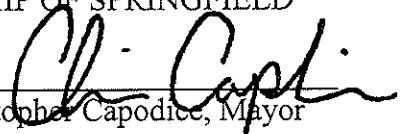
Section 5. That the Business Disclosure Entity Certification be placed on file with this Resolution.
