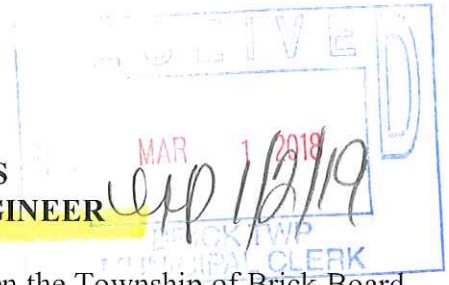


AGREEMENT FOR SERVICES
2018 BOARD OF ADJUSTMENT ENGINEER



THIS AGREEMENT dated the 3rd day of January, 2018 between the Township of Brick Board of Adjustment, a municipal corporation of the State of New Jersey, having its principal offices located at 401 Chambers Bridge Road, Brick, NJ 08723 (hereinafter referred to as "Township") and **CME Associates, 1460 Route 9 South, Howell, NJ 07731** (hereinafter referred to as "Professional"); and

WHEREAS, the Township desires to employ "Professional" to provide Engineering Services for the Board of Adjustment on an as need basis for a term of one year upon Resolution of Award.

NOW, THEREFORE, the parties hereunder do agree as follows:

1. Provide Professional Board of Adjustment Engineering Services to the Township on an as needed basis as directed by the Board of Adjustment.
2. Services may include attendance and participation in any day/evening meetings as called for by the Board of Adjustment.
3. Respond to general questions as posed by the Board of Adjustment.
4. Review and respond to routine correspondence received by the Township for the assigned project.
5. It is agreed that compensation for the scope of services shall be rendered in connection with the approved 2018 rate schedule.
6. "Professional" shall indemnify and hold harmless the Township and their agents and employees from and against all claims, damages, losses and expenses, including attorney fees, arising out of or resulting from the performance of the work provided that any such reasonable claim, damage, loss or expense to the extent (a) is attributable to bodily injury, sickness disease, or death, or to injury to or destruction of tangible property (other than the work itself), including the loss of use resulting there from and (b) is caused in whole or in part of any negligent act or omission of the **Professional**, any subcontractor, anyone directly or indirectly employed by any of them or anyone for whose acts any of them may be liable.
7. The parties to this contract agree to incorporate and comply with the requirements of N.J.S.A. 10:5-31 and N.J.A.C.17:27, Affirmative Action.
8. The parties of this contract agree to comply with the provisions of P.L. 2004, c. 57 and P.L. 2009 c. 315 in regards to Business Registration Certificate.

9. The parties of this contract agree to comply with the provisions of title II of the Americans with Disabilities Act of 1990 (the "Act") (42 U.S.C. 12101 et. seq.) as amended and supplemented from time to time.
10. That the term of this contract commences on the date of award and terminates one year upon Resolution of Award.
