Dear Ms. Darmo:

The Delanco Board of Education is in receipt of your January 4, 2021 Open Public Records Act and common law right of access request. The seven day response period began on January 5, 2021. Please accept this timely response.

Your request sought:

"Contract between the Delanco School District and Barclay Group Inc."

Your request for the document is denied because the District does not have a contract with the Barclay Group, Inc. Your request for access under the common law is similarly denied because no document exists and because your common law request did not contain a reason for the request where the District could balance the interest of your request against the agency's need for non-disclosure.

Nonetheless, in an effort to assist you, the District provides the attached purchase order which demonstrates its payment to the Barclay Group, Inc. Please note, while there is no contract, the District is statutorily required to have the bond in place which necessitated the need for the purchase order.

This response and the attached document completes the District's responsibilities under the Open Public Records Act and the common law right of access.

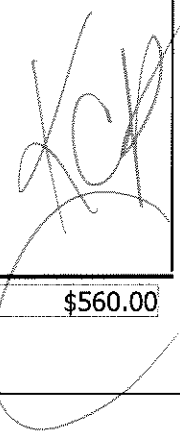
