**REPEAL AND REVISE RESOLUTION AUTHORIZING THE TOWNSHIP OF OLD
BRIDGE'S ACCEPTANCE OF GRANT FUNDS AND PARTICIPATION IN THE PROGRAM
ADMINISTERED BY THE STATE OF NEW JERSEY, DEPARTMENT OF LAW AND PUBLIC
SAFETY – FOR THE BODY-WORN CAMERA GRANT PROGRAM FOR STATE FISCAL YEAR
2021**

WHEREAS, on July 13, 2021, the Township Council of the Township of Old Bridge adopted resolution 21-246 “Resolution Authorizing The Township Of Old Bridge’s Acceptance Of Grant Funds And Participation In The Program Administered By The State Of New Jersey, Department Of Law And Public Safety – For The Body-Worn Camera Grant Program For State Fiscal Year 2021” and the following revisions are being made:

WHEREAS, as the Township of Old Bridge has been awarded a grant from the State of New Jersey, Department of Law and Public Safety, Office of the Attorney General to receive funding from the SFY21 Body-Worn Camera Grant Program; and

WHEREAS, the Township of Old Bridge applied for award number BFY21-100-066-10220-495 for the period January 1, 2021 – December 31, 2025 from the State of New Jersey, Department of Law & Public Safety; and

WHEREAS, the award amount totals \$305,700.00 state award (no match required) and is for the purpose of providing the Police Department of the Township of Old Bridge with funding for the purchase of body-worn cameras, ancillary accessories and storage; and

WHEREAS, the Township of Old Bridge is authorized to accept the award (**Award Number 21-BWC-333**) referenced herein for the purpose stated herein; and

WHEREAS, the Township Council desires to memorialize the Township of Old Bridge’s acceptance of the grant award by adoption of the within resolution.

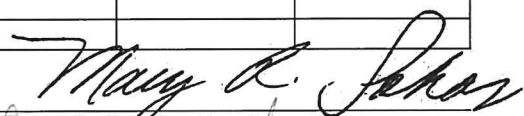
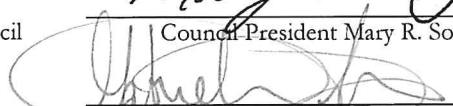
