- 2) developments proposed by any and all developers which included affordable housing components in accordance with requirements issued by the State of New Jersey or any State agency including the Council on Affordable Housing (COAH);
- 3) legal actions filed by the Township with regard to affordable housing requirements issued by the State of New Jersey or any State agency including the Council on Affordable Housing (COAH);
- 4) defense of legal actions filed by any and all developers who pursued developments which would include an affordable housing component in accordance with requirements issued by the State of New Jersey or any State agency including the Council on Affordable Housing (COAH);
- 5) defense against "builder's remedy" lawsuits by any and all developers who pursued developments which would include an affordable housing component in accordance with requirements issued by the State of New Jersey or any State agency including the Council on Affordable Housing (COAH);

Time period to be covered: The year 2008, when the third round obligations for the Township of Wayne were set by the Council on Affordable Housing (COAH) to present.
