Dear Ms. Bowen:

The Evesham Township Police Department Records Custodian received your OPRA request on **September 3, 2024**. The seven (7) business day deadline to respond to your request is **September 12, 2024**. This response to your request is being provided to you on the **6th** business day after the custodian's receipt of your request.

You requested "...Please provide email correspondence between ETPD and the following individuals: Maria Ginter (Pugarelli) Lynn Mangano Mary Haines between August 1, 2024 to present. ..." **Your request is being denied because, after diligent search, there are no records responsive to your request for the dates or names provided. GRC 5-49; GRC 10-325.**

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision by the Evesham Township Police Department to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.

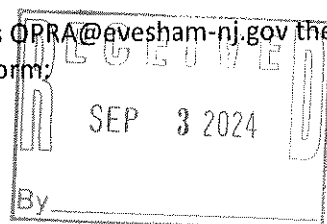
