Dear Sir:

Your opra request for access to public records pursuant to the Open Public Records Act, N.J.S.A. 47:1A-1.1, et seq., was sent via email on Thursday, April 29, 2021 at 4:52pm; however, since the office closed at 4pm, the Custodian of Records received it at 8am on Friday, April 30, 2021. The (7) business day deadline would be today, May 11, 2021. Due to the extent of the records you are requesting, the Borough of Lavallette is going to require an extension of providing you these records no later than Tuesday, May 18, 2021. Any documents that are received from now until May 18th will be forwarded to you as they are received by the Custodian of Record.

N.J.S.A. 47:1A-5(i) as amended March 20, 2020 provides as follows:

[d]uring a period declared pursuant to the laws of this State as a state of emergency, public health emergency, or state of local disaster emergency, the deadlines by which to respond to a request for, or grant or deny access to, a government record under paragraph (1) of this subsection or subsection e. of this section shall not apply, provided, however, that the custodian of a government record shall make a reasonable effort, as the circumstances permit, to respond to a request for access to a government record within seven business days or as soon as possible thereafter.

If your request for access to a government record has been denied or unfilled within the days required by law, you have a right to challenge the decision by the Borough of Lavallette to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
