9. Any deliberations of a public body occurring after a public hearing that may result in the imposition of a specific civil penalty upon the responding party or suspension or loss of a license or permit.

WHEREAS, N.J.S.A. 10:4-13 provides that a public body may not exclude the public from any meeting to discuss any matters described in N.J.S.A. 10:4-12 until the public body has adopted a resolution at a meeting to which the public shall be admitted, stating the general nature of the subject to be discussed and stating as precisely as possible, the time and when the circumstances under which the discussion conducted in a closed session of the public body can be disclosed to the public.

PUBLIC HEARING & ADOPTION

**AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE BOROUGH OF
ENGLISHTOWN AMENDING CHAPTER 2.121.07 OF THE BOROUGH CODE**

WHEREAS; members of the governing body have responded to requests for a revision of the parking prohibition ordinance raised and discussed by citizens at public meetings of the governing body regarding the need for parking on part of Hamilton Street.

NOW, THEREFORE, BE IT HEREBY ORDAINED by the Mayor and Council of the Borough of Englishtown that the following specified section and provision of the Code of the Borough of Englishtown are amended and supplemented as specified below:

ARTICLE I

CHAPTER 2.121 (new language underlined)

2.121.07 Parking Prohibited at all times:

Parking is prohibited on the following specified streets and locations at all times:

Hamilton Street parking restrictions to include the area on the southside between the easterly curb line of Main Street to the easterly curb line of Harrison Avenue. Notwithstanding this provision, parking will be permitted on the southside of Hamilton Street from the easterly curb line of Harrison Avenue to the westerly curb line of Irving Place. Parking will be restricted on Hamilton Street on the north side from the easternly curb line of Harrison Avenue to the westerly curb line of Irving Place.

Additional parking restrictions will be as follows:

Irving Place eastside from the curb line of Hamilton Street to the northernly curb line of Tennent Avenue.

West Dey Street South Side from Main Street to Cul-de-Sac West Dey Street, North Side from Main Street to a point 156 feet West.

Center Street, South Side, from Main Street to Harrison Avenue.

Tennent Avenue, North Side from Main Street to the Manalapan Township Border.

Main Street, West Side from West Dey Street to Water Street from the Northerly Side of the bridge to Water Street. Main Street from the East Side to both Sides, from Park Avenue to Tennent Avenue.

Pine Street, North Side, from Main Street to Harrison Avenue.

ARTICLE II

SEVERABILITY

Should a Court of competent jurisdiction rule any portion, provision, clause or section of this Ordinance Amendment unconstitutional or invalid , such provision shall be deemed severable and shall not affect the validity of the remaining portions provisions or sections of this Ordinance which shall remain in full force and effect.

WHEREAS, in 2020, New Jersey voters approved Public Question No. 1, which amended the New Jersey Constitution to allow for the legalization of a controlled form of marijuana called “cannabis” for adults at least 21 years of age; and

WHEREAS, on February 22, 2021, Governor Murphy signed into law P.L. 2021, c. 16, known as the “New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act” (the “Act”), which legalizes the recreational use of marijuana by adults 21 years of age or older, and establishes a comprehensive regulatory and licensing scheme for commercial recreational (adult use) cannabis operations, use and possession; and

WHEREAS, the Act establishes six marketplace classes of licensed Cannabis businesses, including Class 5 Cannabis Retailer Licenses, for businesses involved in retailing cannabis; and

WHEREAS, pursuant to N.J.A.C. 17:30-7.10 Applicants for cannabis business licenses (“license applicants”) need to submit proof of local support in the form of municipal approval from the governing body as part of their application (cannabis business license applicants); and

WHEREAS, the Borough of Englishtown has vetoed and repealed Ordinance No. 2022-012 on November 21, 2022, the ban on the operation of any licensed cannabis businesses within certain designated areas of its geographic boundaries; and

WHEREAS, under N.J.S.A. 24:6I, if a municipality does not enact an ordinance or repeals an ordinance banning one or more classes of cannabis businesses, then cannabis businesses will automatically be permitted to operate in the following areas for the next 5 years: A cultivator, manufacturer, wholesaler, distributor, or delivery service shall be permitted uses in all industrial zones of the municipality and a retailer shall be a conditional use in all commercial zones or retail zones, though they must still meet any applicable zoning ordinance or get a variance in accordance with the “Municipal Land Use Law,” P.L.1975, c.291 (C.40:55D-1 et seq.). However, the Borough may still pass an ordinance addressing the permissible hours of operation and manner of operation at a later date; and

WHEREAS, the Borough Council has not imposed a limit on the number of licensed cannabis businesses within its jurisdiction, and has therefore determined that the issuance of a license to the below license-applicants by the State Cannabis Regulatory Commission would not exceed any licensing limits; and

WHEREAS, the Borough Council submits no preferences in regard to licensing; and

WHEREAS, in providing this letter of local support, the Borough Council expresses no opinion regarding the completeness of any application, its compliance with the Cannabis Regulatory Commission’s application requirements or any applicable Borough zoning, land use, or planning requirements; and

WHEREAS, Plantopia, LLC is registered to do business in the State of New Jersey and intends to apply to the New Jersey Cannabis Regulatory Commission for conversion of its conditional license to

an annual Cannabis Retailer License to operate an adult-use cannabis retail business within the Borough of Englishtown, New Jersey.

9. Any deliberations of a public body occurring after a public hearing that may result in the imposition of a specific civil penalty upon the responding party or suspension or loss of a license or permit.

WHEREAS, N.J.S.A. 10:4-13 provides that a public body may not exclude the public from any meeting to discuss any matters described in N.J.S.A. 10:4-12 until the public body has adopted a resolution at a meeting to which the public shall be admitted, stating the general nature of the subject to be discussed and stating as precisely as possible, the time and when the circumstances under which the discussion conducted in a closed session of the public body can be disclosed to the public.
