As per our telephone conversation on this date I am respectfully requesting to terminate my health care coverage with the Borough of Chester on ~~August 1st~~^{September 1st}, 2010. 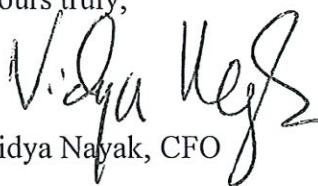
