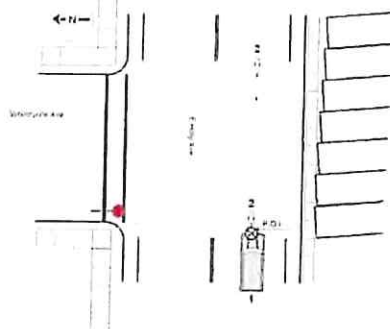

145. Crash Description/Narrative

Investigation at the scene revealed that Driver of Vehicle 1 was traveling East bound on East Holly Ave when he struck the pedestrian. The pedestrian was attempting to cross East Holly Ave at the intersection of Woodlynne Ave. The pedestrian appeared to be halfway through the East bound lane on East Holly when she was struck by Vehicle 1. There was no marked crosswalk at this intersection.

Witness at the scene stated that they were traveling East bound on East Holly Ave when she observed the pedestrian waiting to cross East Holly and Woodlynne Ave. The witness stated that she stopped her vehicle to allow the pedestrian to cross. Witness stated that Vehicle 1 was cresting over the hill, travelling east bound on East Holly, and Vehicle 1 did not appear to be stopping. Witness stated that the pedestrian was already in the East bound lane when Vehicle 1 struck the pedestrian. Vehicle 1 did not stop until after it had struck the pedestrian.
