Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On March 27, 2026 at approximately 2029 hours, I Patrolman Nicholas Romeo #395 arrived on the crash scene located at Hope Chapel Rd and Hope Hill Ln. Upon my arrival, multiple patrol officers were already on scene and had the crime scene taped off.

While on scene, I was advised the victim later identified as D. B. was treated on scene and rushed to Jersey Shore Medical Center for further treatment. Vehicle parts were left behind at the scene of the crash and came back to a 2017-18 Hyundai Elantra. Further into the investigation, video surveillance was obtained from **N.J.** Hope Chapel Rd which captured a 2017 Hyundai Elantra bearing NJ Registration W38VRR heading North on Hope Chapel Rd around the same time the crash occurred and had damage consistent with the broken vehicle parts left at the scene. After making contact with the Jose Perez-Parada, he stated that he was driving in that area and struck an unknown object in this vehicle. Jose stated he did not stop or call 911 after striking whatever he struck and continued home with the flow of traffic.
