Note

On September 8, 2020 at approximately 1951 hours, Hillsdale Communications received a call from Mr. Scott Pierson, of 13 Fairview Avenue, reporting that his neighbor at 14 Magnolia Avenue was playing loud music and he wanted to speak with an officer.

At this time, P.O. Cottrell and I arrived at 14 Magnolia and attempted to make contact with the owner, later identified as Teresa Minafri, but were unsuccessful. Hillsdale Communication was able to make contact with her via telephone and she stated that she wasn't home. We then made contact with Mr. Pierson at 13 Fairview Avenue. As I stepped out of my vehicle to speak with the party, I immediately heard a very loud radio playing directly at Mr. Pierson's house. Mr. Pierson stated that Ms. Minafri continues to play the radio at all times of the day for hours straight and even when she isn't home. On some days, she would play the radio close to eleven and twelve hours. Mr. Pierson explained how the issue with his neighbor's harassments have gone on for about a year with a different situation each time. He stated that Ms. Minafri is getting retaliation with playing the radio for a separate incident that happened recently where Mr. Pierson called the police. (See. Mr. Pierson's sworn statement.)

I advised Mr. Pierson about his possible options and he stated he would like the incident documented. He advised me that he was interested in signing complaints, but didn't have the time at that moment. Mr. Pierson's sworn statement has been scanned in and attached to the case file.

On August 20, 2020, at approximately 0746 hours, Hillsdale Police Communications received a phone call from Scott R Pierson, of 13 Fairview Avenue, reporting that his neighbor from 14 Magnolia Avenue, keeps throwing tissues, cigarette butts, and cigarette boxes onto his property. Mr. Pierson stated he wanted the police to respond to the neighbors address and to make a notification to the neighbor to stop those actions.

At this time, I was dispatched by Hillsdale Police Communications to respond to 14 Magnolia Ave. Once I arrived, I attempted multiple times to make contact with the owner, who was later identified as Teresa A Minafri, but she never answered the door. Sgt. Zimmerman #66 was able to get Ms. Minafri's telephone number and made contact with her. She advised her about the complaints made against her, but Ms. Minafri denied all accusations.

At approximately 1542 hours, Mr. Pierson came in to Hillsdale Police headquarters to complete a written sworn statement about his accusations against Ms. Minafri. He stated, he wanted to file a report but does not want sign any complaints at this time. Mr. Peirson completed the sworn statement, in which he described his ongoing issues with Ms. Peirson. To furthermore explain into detail, he stated Ms. Minafri on multiple occasions has thrown cigarette butts, tissues, and cigarette boxes on his property. She would also push all the leaves and trees onto his property causing a mess.

Mr. Pierson furthermore reported that Ms. Minafri had also approached him in the past without a face mask, which he believes is dangerous due to the current pandemic. He continued to state that she is dangerous to him and his family and wants Ms. Minafri to stop harassing them. (See Mr. Pierson's statement regarding details).
