Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On Tuesday, December 10, 2024, at approximately 7:09 a.m., police officers responded to a residence on Sharrowvale Road in Cherry Hill, New Jersey, for a report of a male who was bleeding heavily. Officers arrived on scene and located the victim, later identified as Dr. Michael J. Anthony, who had sustained multiple penetrating wounds and was lying unconscious on the front yard of the residence. A pair of eyeglasses were located near the victim. The victim was later pronounced deceased.

Detectives reviewed surveillance footage and observed the victim walking outside at approximately 5:24 a.m. Detectives also heard multiple loud screams at approximately 5:53 a.m.

Detectives reviewed footage from numerous locations and identified a sedan entering Route 70 from the area of Haddon Township at approximately 5:24 a.m. The vehicle entered the victim's neighborhood at approximately 5:30 a.m. and veered right onto Sharrowvale Road. At approximately 5:55 a.m., a vehicle with the same characteristics drove away from the crime scene and travelled out of the neighborhood.

Through investigation of the eyeglasses located at the crime scene, detectives learned the prescription of the lenses and that the frames had been sold in Washington State.

Detectives identified that suspect Cristian L. Custodio-Aquino had been acquainted with the victim. The suspect owned a black sedan, which entered New Jersey in October of 2024 and had been in the area of Haddon Township until December 8, 2024. Detectives further learned that the vehicle was in Pennsylvania on December 10th, approximately one hour after the screaming recorded in video. On December 11th, the vehicle was detected in Florida and then in Alabama and Texas.

Detectives obtained images of Aquino's vehicle, which were consistent with the vehicle which traveled from the area of Haddon Township, entered the victim's neighborhood shortly before the homicide, and then left after the screaming recorded in video.

Detectives learned from a retailer in Washington State that Aquino had purchased a pair of eyeglasses matching the model and prescription of the eyeglasses which were located at the crime scene.
