Mr. Pasculli,

The Raritan Township Clerk's office, the official Records Custodian, received your Open Public Records Act (OPRA) request on December 22, 2022. As such, the seven (7) business day deadline to respond to your request is January 5, 2023. A response to your request is being provided to you on the fourth business day after the custodian's receipt of said request. Your OPRA request sought access to the following:

"List of all current police officers and their badge numbers"

The following information is being provided in its entirety and is responsive to your request:

One page list of all current police officers and badge numbers

The record is being provided via email as per your request.

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision by the Township of Raritan to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
