On Friday 03/08/24 at approximately 2239 hours, I responded to the above address for the report of a physical altercation. Sgt. McCarthy and Ofc. Van Gilder responded as backup.

Patrol was initially dispatched for a stand-by as a precaution regarding a fight that occurred involving juvenile hockey players, unknown names, but that had been resolved without incident.

Upon arrival, I observed Sgt. McCarthy and Ofc. Van Gilder already on scene.
